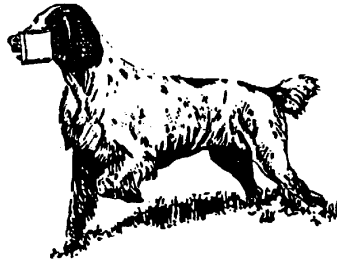

DIRECTIONS TO THE TRIAL SITE

From the North or South: U.S. 23/I-475 to Exit 4 US-24W towards Napoleon, take exit 66 toward Anthony Wayne Trail/Waterville. Turn left onto OH -295S/Bridge St, Grand Rapids Rd, turn right on Front St, left onto Wapakoneta Rd turn rt on 1st cross street onto W Second St. Turn left onto Henry Wood County Rd (Cty Rd 1) 1.7 miles on the right (just after Rd P)

From the East: Ohio Turnpike to I-75 South towards Bowling Green, Exit 179 for US-6 W. Turn right on Henry Wood county Line Rd (Cty Rd 1). Leach Farm on the left just before Rd P

From the West: Ohio Turnpike to Exit 34, head south on 108, get on US-24/US-6 E in Napoleon, follow the exit for US-6. Turn left on Henry Wood County Line Rd (Cty Rd 1) Leach Farm on the left just before Rd P.

Test Regulations

Proof of current rabies vaccination must be furnished upon request.

All dogs must be held on leash (no FLEXI leashes). Dogs must be kept a suitable distance away from the test area. Handlers should bring water and provide shade for their dogs. Handlers are required to pick up after their dogs...duh...

NOTICE TO EXHIBITORS

Faxed, Telephone and Unsigned Entries cannot be accepted. Entries Not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**.

The same entry form may be submitted for both Trials, provided that a separate entry form is submitted for each dog, that the classes for each Trial are indicated, and that all information is the same for both days. If any information is different, please submit separate entry forms. Please advise trial secretary of any errors. All exhibitors providing an email address will be sent a preliminary email confirmation.

Make All Checks and Money Orders payable to: Toledo Kennel Club. CANADIAN exhibitors must make fees payable in US FUNDS. Please mail checks or money orders with entries. The Trial Secretary assumes no responsibility for cash sent through the mail.

Mail All Entries with Fees to: Barb Bumcrots 2509 Seventh St, Maumee, OH 43537.. Entries received without fees will not be accepted. Acknowledgment of entries will be made as soon as possible after the closing date with the Judging Program and directions to the Trial Site. Should such acknowledgment not be received by the exhibitor within a reasonable time, please contact the Trial Secretary. **Overnight or express entries MUST have waiver of signature. Failure to do so may result in your entry not being picked up in a timely manner.**

No Entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the trial, no refund of entry fees will be made.

Post Dated and Returned Checks do not constitute a valid entry fee. The trial giving Club will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

Errors on Entry Blanks. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellations of entries after the published closing date.

All Dogs Present must be held on leash or confined to their crates except when being judged.

No gasoline or diesel generators are permitted inside of any building or within 100 feet of the show grounds on which this obedience trial is conducted. No electrical hookups will be available.

No Smoking is allowed at the trial site: The Leach Farm

The grounds will not be available to the exhibitors and their dogs on the nights prior to the trials.

Neither the Trial Committee nor the Toledo Kennel Club will be responsible for the loss or damage to any dog on the trial grounds, whether as a result of an accident or any other cause. It is clearly understood that every dog entered in the trial is in the care, custody and control of its owner or handler during the entire time the dog is on the trial premises.

The club may decline entries for cause and may refuse to receive or remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against the club or any official thereof. **Females in season may not enter.**

AKC Event & Recording Fees will be required for the first entry of each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking test. The fees are to be collected by the trial-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Fees are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2). The recording and event fees are included in the entry fee.

A dog must be entered in the name of the person who actually owned it at the time entries for the FDC test or trial closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any FDC test or trial for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his or her name. State on entry form whether transfer application has been mailed to AKC (for complete rule refer to Chapter 14, Section 3 of "Rules Applying to Registration and Dog Shows").

AGREEMENT

I (we) acknowledge that the "Rules Applying to Registration and Dog Shows" and the "Rules for FDC Tests & Trials" have been made available to me (us), and that I (we) agree that the club holding this FDC Test or Trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the FDC Test or Trial and of the opportunity to have the dog tested or judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the FDC Test or Trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this FDC Test or Trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons. I (we) will pay for any livestock injuries or replacement value in the event of death of any livestock by my (our) dog. In case if any injury to any stock caused by the dog entered, I (we) will assume total responsibility for any damage. I (we) agree to pay the full market value of the injured animal in case of serious injury, or the veterinarian bill if the injury is slight.
